#### 7. OFFICIATING REPORT

- 1. Preparations have commence for the 2024 Sydney Hockey Season with several of the 2023 Committee engaged in planning discussions for 2024. The next step is to hold the Officiating Annual General Meeting (AGM) to elect the 2024 Sydney Hockey Officiating Committee. At this time it is proposed to conduct the Officiating AGM on Monday, 19 February at 7:00 PM at a venue yet to be determined. Unfortunately Scott Evans has advised due to family illness he may have limited availability in 2024, however, the current President is maintaining regular contact with Scott in order to maximise his availability this season.
- 2. Following tonight's meeting the first Officiating Newsletter will be sent out to all members advising them of the 2024 Season and inviting club to seek umpiring assistance for trial matches.
- 3. At the next Board meeting (29 Jan 24), it is anticipated that a decision will be reached on the Officiating Uniform, Ball Person T Shirts and the Supplier for of Officiating Apparel for 2024.

### 9. GENERAL BUSINESS

- Ku-Ring-Gai pitch. Reps from GNS & NSBHA were invited to attend to discuss their desire for SH to use the newly re-laid pitch at Ku-ring-gai.
- Printed info was viewed and explanations were given by David the Polytan rep and contributions to the discussion were made by the other visitors trying to impress on the need to use this 'new generation' sand filled pitch
- Current president of GNS talked about how players would be learning for the future

- PB asked some clarifying questions about why this type of pitch was chosen and discussed what other facilities had been included/updated at the venue. – Basically Money, Grants and the pitch being on Education Dept land.
- It was noted that the carpark and lighting to and from the field will not be updated this season, scheduled for Summer 2024.
- It was mentioned by PB that fees players pay to NSBHA received nothing in return- blankness in reply.
- BC discussed how GNS might introduce players to the surface by hosting preseason games – SH would provide umpires
- PB and the meeting thanked the visitors for attending the meeting and asked that some promotional material be developed to help sell to SH member clubs why it is necessary to play at Ku-ring-gai
- Resolved to agree to use the facility, dependant on the promotional info to be provided

### **UTS PL nominations**

- UTS have nominated 3 x PL teams. Paul was invited to attend the meeting to discuss the viability of the nominations.
- Paul discussed the background with the University in having a higher profile within the university basically for funding (?) and the progress made in the development of a junior base within the local community surrounding SOP
- Paul mentioned a re-banding exercise for the club, to be now called 'UTS Raptors'
- Questions were asked of a player base for the PL teams discussion around recruitment proceeded to an acceptable level.
- Mention was made of the need to contribute to Umpire ranks
