#### 8. OFFICIATING REPORT

This current weekend saw Round 3 of the 2022 Sydney Hockey season being conducted. As in previous weeks COVID has been a determinate in Official's availability. Availability for Round 3 was further complicated as the following Hockey activities were being conducted involving our members:

- State Centre of Development ran a Tournament at Wagga,
- The NSW Masters 34/40 Championship was conducted at Nepean,
- The National 15's Championship was being conducted at Newcastle, and
- The National 18's Championship was being conducted at Cairns.

Despite other activities the Officiating effectives was 93% and 94% for Rounds 1 and 2 as follows:

Some Clubs have the required one team/one official ratio such as Northern Districts and Wests whilst others contribute no officials to Sydney Hockey Officiating. This imbalance is being pointed out to the Clubs and they have been requested to address the imbalance.

All 2022 pre-season Official's expenses have been paid and Round 1 and 2 Expenses are with Executive Officer. The next expense run will be paid at the end of April.
