5. PRESIDENTS REPORT

- PB welcome the visitors representing Clubs & Presidents to the meeting
- PB outlined that 2019 would be a challenging year, a number of new teams entering the comp ; transition year in the PL grades. Need to respect the contribution made to Sydney Hockey by the SL grades (At time of printing we have 96 teams competing this year, this is an increase of 5 teams over 2018)

- There has been much discussion on What clubs are wanting from the competition Club Hockey is a regular titled used but what is it? There are varying views on its definition.
- 2020 structure the Board expects to announce in April, the proposed structure for next year. There has been much discussion of PL grades with the though that clubs need to provide coverage of PL grades if to be regarded as a PL club;
- Anthony & Mike both asked questions about the future structure and noted that it is difficult for clubs to provide 3-4 grades of PL players.
- PB noted that the Board has adjusted its trading name to Sydney Hockey. This is in a effort to show what our current role is – A competition body. This is how we are viewed by Hockey NSW. At the same time we are aware of a moral responsibility to provide a pathway for Juniors into the senior ranks. He noted that the Metro Cup comp is reduced to a handful of teams in U15's & U17's.
- PB has had a discussion with Craig Colvin the new President of Hockey NSW where he is keen for us to have more involvement in future plans.
- PB thanked Peter, Bruce & Robbie for the work put in to preparing the draw.

6. BUSINESS ARISING

- Competition Rules will be distribute. Minor changes to the wording in relation to Revolutionise data entry; change in fines as outlined in previous minutes; including change to 1st week of finals if a top six is played.
- Question re Shirt Numbers the Board is looking for unique numbering in PL grades
- No change to player eligibility from current rules
