## 7. OFFICIATING REPORT

As mentioned in last month's, July Officiating Report, the current structure of the Draw with teams and grades widely dispersed and fewer late games is making difficult to appoint to all games in 2019. This is further compounded with more playing umpires than previous years. Despite this there have been some pleasing results as often when a Club Umpire is appointed, the Club Umpire is often an Official Umpire that officiates at the game. The following is a summary of the last four weeks appointments.

In preparation for the 2020 competition, the Chair is in discussions with an International Badge Umpire to form a Coaching Clinic in 2020 for a small select group of . **Approval is requested** that if the negotiations are successful that the Umpire Expense payment for this International Umpire only will increased from \$60 to \$100 per game.

Finally as we planning for the 2019 Sydney Hockey presentation night, the Officiating Committee is **seeking approval not to award** the Junior Umpire of the Year in 2019 as there few if any candidates. – Agreed
