## **8 OFFICIATING REPORT**

The 2018 Sydney Hockey Association is now well and truly begun for the Officiating Committee. Prior to the start of the season an Annual Meeting was conducted on 5 April 2018 to elect the 2018. The Committee is:

After the Annual Meeting Zeke Newman conducted a question and answer session using televised game clippings that greatly assisted with the flow and structure of the evening. As a result of the evening a similar session entitled a Calibration Evening is being conducted on Monday 16 April 2018. This evening has been restricted to the Premier League First Grade officials (umpires and Technical officials). In addition to the officials each PLI Captain and Coach has been invited. The aim of the evening is to calibrate everyone's appreciation of the ways the rules for the 2018 season will be applied. Also prior to the season SHAO provided the umpires for 20 club organised preseason games. This was well received by the clubs and provided a great opportunity for the Umpires to gain some preseason training.

Round 1 (Premier League only) - All appointments were filled during Round 1.

Round 2 (All grades) - SHAO is still reviewing the match reports from last weekend however a number of new umpires were inducted and assessed. Also the (4 sets) new radios have been received and trialled during Round 2 both at PL & SL games and have proved already to be a great asset.

Hockey NSW - Hockey NSW has advised of the appointment of Zeke Newman as the Holkey NSW, Umpire and Officials Development Manager. Bruce Cook has been offered and accepted a position on the combined panel. Previously Bruce was a member of the Technical Officials Appointment Panel. Zeke has already started work and has announced a new Umpiring Accreditation Structure (Bruce then outlined the process).

SHAO has two requests:

- o Officials to receive a minimum of one payment per month; and
- o Increase to the Umpire Expense allowance from \$40 to \$50 per game.
  - Meeting resolved to increase Umpire Coach rate to \$60, (moved BC, 2<sup>nd</sup> RMc)
  - Bruce discussed Norther Area umpire coaching request and action.
  - Bruce noted that PL1 & 2 TO's need to note time when game stopped and restarted, to ensure rule for when a game is complete can be satisfied.

9. **FINANCE REPORT**

- Meeting resolved to accept Budget as presented in April, average of \$433 per game
- Umpire payments agreed to be made monthly

10. **General Business**

- Further general discussion on future comp structure – resolved to devote significant time at a future meeting to map out a plan.
