5. 2018 ANNUAL REPORT

Presidents Report – Presented by Peter Busch as appears in Annual Report.

Peter discussed various aspects of his report, including challenges in 2018 with the Competition Structure and he thank all for contributing to a successful year non the less. Peter thanks the Officials Committee headed by Bruce Cook and Robbie Sutton for achieving 95% coverage of matches with qualified umpires. Likes Peter thanked Rohan for his efforts with the Finance portfolio. He made mention of the tremendous efforts put in by Peter Hayes as Executive Officer to keep the Competition humming along.

He noted some difficulty with keeping hold of open dialogue amongst the clubs and reminded clubs that committee meetings are open of clubs to attend and discuss matters if they wish. Through the year it was clear that the concept of "Çlub Hockey" was a driving force in structuring new competitions and plan for 2020 was circulated in April. Mention was made of the re branding of SHA to Sydney Hockey, because the name better reflects our role as a Competition Organisers /Facilitators.

Finance Report – The Finance Report which was detailed in the Annual Report. Rohan was not present to answer detailed questions. 8. General Business -

A number of topics were discussed in a conversational format, including

- Paul Economides asked about Sydney Hockey's relationship with Hockey NSW – PB – mentioned efforts to have a rep on the board, the contribution Sydney Hockey make through umpire & player development and our wish to increase the voice we do not seem to have with Hockey NSW.
- Mentioned likely season dates for 2020 – a little complicated by occurrence of Anzac Day and heavy rep schedule in April/May
- Eligibility of National Players; clubs invited to give input. Board to review as part of rule review that is currently underway.
- Paul E asked about the 2020 structure and number of rounds, PB repeated the structure details that have been advertised, as the way forward in 2020.
- Some change is being planned though using Revolutionise software more, that also includes the use of numbered shirts and player photos, TO/use of sideline tablets, and umpire coaching plans for 2020. It was noted that coaching in SL grades was also required.
- It is intended to present the rules re-write at the Presidents meeting in March.
- Noted that the rules ask for clubs to provide umpires where SH are not able to. Intention is for Clubs to provide names at the beginning of the season that will be called on. It was also noted that some clubs have been providing no umpire input.
- John Walzak asked about Fines and information needs to come out earlier.
- PB noted that our constitution will be rewritten following the NSW rewrite that is currently underway.
